The trustees present their report and the accounts for the period ended 31 March 2021.

Objectives, organisation and activities:

Ranaviru Fund is an unincorporated association concerned with the relief of those in need by reason of age, ill health, disability, financial hardship or other disadvantage people in the community. It is a registered charity, number SC041479.

The objectives of the charity are:

To provide medical, rehabilitation, welfare and social assistance for the fallen, missing, disabled and wounded Army, Navy, Air Force, Police and Civil Defence Forces members (hereinafter referred as the "Soldier" or "Soldiers") and their immediate family members in Sri Lanka.

It makes grants, donations, loans, gifts or pensions to individuals and to organisations.

Trustees of the Ranaviru Fund have the pleasure of producing this report for the Financial Year 2020-2021.

A total of £3,458 carried forward from the financial year 2019-2020.

A total of £2,711 received as donations during this year with no bank interest received during this financial year.

During the financial year the charity has invested £1,578 in charitable activities while £29 spent on subscriptions and professional fees.

At the end of the financial year 2020/2021 a total of £4,562 retained in the charity's bank account.

Every possible measure has been taken by the Trustees of the charity to minimise the administrative costs and other operational costs of the charity to a minimum.

Details of Activities

COVID-19 Relief Food Donation

Ranaviru Fund provided £259.78 (LKR 60,000.69) to Sumedha Mathota of Help Hand Foundation to provide dry food rations to 30 underprivileged families in the Bellan Kadawala village in Anuradhapura district on behalf of the Ranaviru Fund. These dry food rations were provided to the least benefitted villagers in rural Sri Lanka during the height of the COVID-19 pandemic.

Dry Food rations (each appx worth LKR 2,000 - bill attached for LKR 60,750.00) were distributed to 30 families on 13th May by Most Venerable Thero, at the Kiralawa Temple, a local Buddhist Temple in the area.

Capital Funding for Dried Fish Shop

"It is not to be a king but to try to live" Corporal Somatilaka's 'Pulmude Dried Fish Shop'

Corporal Somathilaka is a very courageous father...another needy war hero retired from the army.

It has become very difficult and painful for Corporal Somathila to support his family by selling handkerchiefs on public transport to earn his living. Therefore, he has embarked on a task that he can carry out without any trouble or suffering. In Somatilaka's own words, "trying to live, not to be a king". Apart from that, Corporal Somathilaka was a great father who managed to get both of his elder children into the Defence Forces. But he has another daughter and son to provide education.

Pulmude is an area that produces the highest quality dried fish in Sri Lanka. We are of the opinion that we should wholeheartedly support this effort to live without causing any trouble to anyone and to provide the necessary education to their four children. With the support of the Ranaviru Fund and a group of our friends, Somatilaka started a business of dried fish. He goes to Pulmude and brought the best dried fish and sold it with a reasonable profit.

He told us that the so-called "Karawala counter" is located in Gampaha Topogoda area, Mandawala North, near the Sri Jayawardenaramaya temple.

Ranaviru Fun provided the necessary capital fund for Cpl Somathilaka to initiate this business, a sum of LKR 15,000 (GBP 67.50) offered to Cpl Somathilake to initiate his small business.
